WELCOME/CALL TO ORDER

The meeting was called to order by Juan Romero, Categorical Programs Advisor, at 3:38 p.m.

REVIEW OF THE SCHOOL SITE COUNCILS ROLE AND RESPONSIBILITIES/Orientation

Juan Romero, Categorical Programs Advisor gave a brief School Site Council regarding the purpose and function of School Site Council, the roles and responsibilities of members, provided an explanation of the election procedures and informed participants that there were 5 seats for parents/legal guardians and community members, if they choose to designate seats. SSC Parent/Legal Guardian and Community Member Election

Juan Romero, Categorical Programs Advisor was the electioneer and declared all seats vacant. He informed the participants that, according to their Bylaws, there were 5 seats available for parents/legal guardians/community. He reminded them that only parents/legal guardians can elect SSC parents/legal guardians and community membership. He also informed them that all parents/legal guardians must take a vote before the election process is open to decide whether or not any seats will be designated to community members.

Motion regarding Community Membership on School Site Council: Juan Romero, Categorical Programs Advisor clarified what it meant to give seats to the community members, and they would speak and vote in their place. He asked parent/legal guardian to make a motion regarding the allocation of seats to community members, although there weren't any community members present and recognized Maria Isabel Gonzalez who made the first motion and seconded by Yeimi Orozco. In favor (8), opposed (0), abstained (0), the motion passed.
